The Friends of Valley Forge engage in contract services in order to promote the park, increase attendance, and drive membership increases through marketing, communications and membership fulfillment. These expenditures are considered a vital and integral part of maintaining the organization and are difficult or impossible to break out of total revenues of the organization.

4b (Code:) (Expenses \$ 91,722. including grants of \$ 0.) (Revenue \$ 193,088.)

The Friends of Valley Forge promote park awareness through collecting general donations, and collections for specific park projects and special events to enhance the park and the visitor experience while at the park. The Organization had expenses incurred from their annual appeals, rev run funds and speaker series at the park. The total revenues are difficult to determine, but the number above represents all other contributions and gifts received.

4c (Code:) (Expenses \$ 43,979. including grants of \$ 0.) (Revenue \$ 0.)

The Friends of Valley Forge began paying a few part-time and temporary employees beginning in the fiscal year 2015, to help with membership support services, promotion of the Organization and other general administrative expenses and costs. It would be nearly impossible to quantify their contributions, due to the subjective nature of the work.
